1. GENERAL PROVISIONS

- 1. The Republican Small Olympiad among organizations of secondary specialized and vocational education (hereinafter referred to as Republican Small Olympiad) is held by the Kurmangazy Kazakh National Conservatory (hereinafter referred to as the Conservatory) in order to ensure the training of quality specialists in the field of musical art, and the development of the creative abilities of children and youth.
- 2. These Regulations have been developed on the basis of the order of the Ministry of Education and Science of the Republic of Kazakhstan "On approval of the List of republican and international Olympiads and competitions of scientific projects (scientific competitions) in general education subjects, competitions of performers, competitions of professional skills and sports competitions" (dated December 7, 2011, No. 514) and the Charter of the Conservatory (dated September 12, 2022, No. 53).

2. GOALS AND OBJECTIVES OF THE OLYMPIAD

- 3. The Republican Small Olympiad is held for the purpose of selecting and supporting the most talented and gifted students of specialized schools and colleges, developing their professional abilities to support and preserve the best traditions and achievements of musical culture and performing arts of the Republic of Kazakhstan.
- 4. The main part of the RMO is the further improvement and development of professional music education in the Republic of Kazakhstan, stimulation of creative activities of specialized schools and colleges, disclosure of the professional and personal potential of participants, their creative abilities, creation of conditions for self-realization and self-affirmation.

3. CONDITIONS AND DATES OF THE OLYMPIAD

- 5. The Republican Small Olympiad is carried out online at the Kurmangazy Kazakh National Conservatory.
- 6. Students of graduating (10-12) grades of secondary specialized music schools and 3rd-4th year students of music colleges can take part in the Olympiad.
- 7. Republican Small Olympiad is held in the following specialties and nominations:
 - Composition;
 - Music Theory;
 - Piano;
 - String instruments in the nominations: "Violin", "Viola", "Cello", "Double Bass", "Classical Guitar";

- Wind and percussion instruments in the following categories: "Woodwind instruments", "Brass instruments", "Percussion instruments";
- Conducting in the nomination: "Choral Conducting";
- Academic singing in the nominations: "Male Voices", "Female Voices";
- Folk instruments in the nominations: "Dombyra", "Three-stringed Instruments", "Folk Instruments", "Kyl Kobyz", "Prima Kobyz", "Bas Kobyz", "Bayan, Accordion";
- Traditional singing in the following nominations: "Folk singing", "Zhyrshylar".
- 8. Republican Small Olympiad is held by the Conservatory annually in March April;
- 9. Information on each nomination (regulations, requirements, application form, dates) is posted on the conservatory's website in the "Olympiads" section;
- 10. The chairman and jury of the Republican Small Olympiad are formed from representatives of the teaching staff of the Conservatory and leading specialists of musical institutions of the Republic of Kazakhstan in an odd number;
- 11. The Chairman has 2 votes when voting, members of the commission 1 vote;
- 12. Participants who take prize places are awarded the title of laureates of the small Olympiad and are awarded diplomas of the 1st, 2nd and 3rd degrees;
- 13. The deadline for submitting applications for participation in the Republican Small Olympiad expires 2 weeks before the start of the competition for specific nominations;
- 14. Students who have passed the internal selection at the university where they study are allowed to participate in the Republican Small Olympiad. Laureates of the first prizes of the Republican Small Olympiad of previous years are not allowed to participate in the Olympiad.

4. RIGHTS AND RESPONSIBILITIES OF ORGANIZERS

- 15. For the organization and holding of the Republican Small Olympiad, the composition of the organizing committee is approved by order of the Rector of the Conservatory, determining the general procedure for holding the Republican Small Olympiad;
- 16. The list of jury members and responsible persons for each nomination are determined by the organizing committee of the Republican Small Olympiad and approved by order of the Rector;
- 17. The procedure for holding the Republican Small Olympiad for each nomination is determined by the relevant department of the Conservatory;
- 18. The Organizing Committee coordinates the work of the relevant departments in sending out information letters to potential participants of the Republican Small Olympiad, makes proposals on the procedure for its holding and awarding;

- 19. The relevant departments have the right to reject applications that do not meet the requirements for Republican Small Olympiad participants in the specified program.
- 20. The Organizing Committee organizes photo and video filming, the materials of which belong to the Conservatory, and the participants, by applying, automatically give consent for their use on the resources of the Conservatory.

5. RIGHTS AND RESPONSIBILITIES OF PARTICIPANTS

- 21. Participants have the right to receive information about the terms of the Republican Small Olympiad.
- 22. Republican Small Olympiad participants are obliged to comply with this Regulation and perform all actions related to participation in the Olympiad.

6. SUMMING UP AND AWARDING PARTICIPANTS

- 23. The results of the Republican Junior Olympiad are summed up by the jury for each specialty consisting of the chairman and members of the commission approved by the order of the Rector of the Conservatory.
- 24. The winners of the Olympiad are awarded 1st, 2nd and 3rd places as follows:
 - 1st place one laureate diploma;
 - 2nd place two laureate diplomas;
 - 3rd place three laureate diplomas.
- 25. Additional incentives for participants for the best performance in various nominations, established by the specialized department (no more than 2 for each nomination) are possible;
- 26. The jury has the right: to award not all prizes and diplomas, to award diplomas for the best performance.
- 27. The decisions of the jury on specialties are final and are not subject to revision.

7. FINANCIAL CONDITIONS

28. Participation of students of secondary specialized and vocational education institutions in the Republican Small Olympiad is free of charge.

8. PROCEDURE FOR MAKING AMENDMENTS

- 29. Proposals for making amendments and additions to this Regulation shall be discussed at a meeting of the Academic Council and shall be accepted or rejected by a majority vote (at least 2/3 of the votes of the number of members of the Academic Council present at the meeting).
- 30. Amendments to the Regulations are made only by decision of the Academic Council of the Conservatory on the basis of a service letter from the head of the educational and methodological department, agreed upon with the vice-rector for academic and educational and methodological work.

- 31. Amendments to the Regulations are made in accordance with the requirements of the QMS with a mandatory note in the "Registration Sheet of Changes".
- 32. Notifications about changes in the procedure are sent to all departments and responsible structural divisions of the Conservatory.
- 33. The original of the Regulation is kept in the documentation department. Copies of the methods are sent to the structural divisions of the Conservatory by the educational and methodological department.

9. FINAL PROVISIONS

- 34. This Regulation, as well as any amendments and additions thereto, shall be approved by the Rector of the Conservatory and shall enter into force after such approval.
- 35. The provisions are mandatory for execution and may be changed or supplemented in connection with changes in regulatory documents or the emergence of new additional costs not taken into account in this document.
- 36. Other issues arising in the implementation of the provisions of the Regulations shall be resolved in accordance with the Charter of the Conservatory or the current legislation of the Republic of Kazakhstan.
