1. General provisions

- 1. These Regulations regulate the procedure for reducing the cost of tuition for students (hereinafter referred to as discounts) who study under agreements on the provision of paid educational services concluded when applying for training at the expense of an individual and /or legal entity (hereinafter referred to as an agreement on the provision of paid educational services) in order to strengthen the motivation of students studying at the Conservatory high educational results.
- 2. The Conservatory has the right to reduce the cost of paid educational services at the expense of the Conservatory's own funds.
- 3. These Regulations are intended for use in the work of the Commission, deans of faculties, including the financial and economic Service, accounting.
- 4. The regulations have been developed to provide social support to enrolled students in the State University "Kazakh National Conservatory named after A. A. Abramovich". Kurmangazy" (hereinafter referred to as the Conservatory) on a paid contractual basis, as part of the Conservatory's mission to train competent and competitive specialists for the region and the country.

2. Terms of providing discounts and benefits for tuitionfees:

- 5. Discounts on tuition fees are provided to:
- citizens of the Republic of Kazakhstan;
- students studying on apaid basis in educational programs: higher and postgraduate education (bachelor's, master's, doctoral studies).
- 5.1. Discount is passep the amounts of money by which the price of educational services is reduced for a certain period, provided that the student fulfills certain conditions necessary to receive a discount (benefit), i.e. necessary to change the price of educational services by reducing it in each specific case.
- 5.2. Benefit-provided to students in the form of an increase in the time frame for paying tuition fees (for example, not in two tranches, but monthly).
- 6. Types of discounts and benefits:
- increase of payment terms (monthly payment);
- for persons with disabilities (disabled people);

- for persons raised by one parent (single mother/father or in case of death of one of the parents);
- for persons who have parents with established disability of group 1 or 2;
- for people from large and low-income families;
- for persons with a significant deterioration in their financial situation.
- 6.1. Benefits for increasing the payment deadline (monthly payment) are provided to students with an initial payment for training in the amount of 10% of the annual cost based on an individual monthly payment schedule, with a full repayment period until June 1 of the current academic year, with providing certificates of income and family composition.
- 6.2. Discounts for students with disabilities are provided to students (disabled people) who have a medical and social expert opinion, depending on the financial situation of the family.
- 6.3. Discounts for students from large and low-income families are provided to students who have supporting documents.
- 6.4. Discounts for students are provided to students in case of a significant deterioration in their financial situation compared to previous periods of study. A significant deterioration in the financial situation is understood as the occurrence of circumstances that affected the financial situation of the student as a result of emergency events that the student could not have foreseen, prevented or influenced and for the occurrence of which he is not responsible, including natural disasters, fire, loss of breadwinner, etc.
- 7. Discounts (benefits) for students are provided by the decision of the Commission on the basis of an application for a period of one academic year.
- 8. Students 'applications for payment discounts and documents confirming the grounds for granting discounts are initially considered in the deans' offices, and then, if they meet the requirements of these Regulations, they are recommended for consideration by a special Commission of the Conservatory.

Applications are submitted at the beginning of each academic period (no later than September 7 and no later than February 7).

- 9. Each student who applies for payment discounts must submit the following documents:
- application addressed to the rector;
- a photocopy of the identity card;

- certificates confirming various grounds for granting payment discounts.

If necessary, the application may additionally be accompanied by notarized copies of documents related to personal and family circumstances.

10. A discount on payment for educational services is not granted if the applicant does not have the grounds provided for in these Regulations, as well as in case of violation of the terms of payment for educational services established by the agreement.

3. The amount of discounts and benefits provided:

- 11. The amount of tuition fees for specialties is determined by the order on the cost of training students for the next academic year.
- 12. The established cost of paid educational services may be reduced in the amount of no more than 10% by providing discounts and benefits if students meet the conditions of these Regulations.
- 13. If the applicant is entitled to discounts on several grounds, one of the most favorable discounts for the student is provided.
- 14. Students who do not pass the exams within the established time frame for no good reason and violate the internal order of the Conservatory, from the next academic semester are deprived of discounts.

4. Procedure for making changes:

15. Amendments to the Regulations are made in accordance with the current legislation of the Republic of Kazakhstan and internal documents of the Conservatory.
