1. GENERAL PROVISIONS

- 1. These Rules for awarding the title of "Best Teacher of a Higher Educational Institution" (hereinafter referred to as the rules) have been developed in accordance with Order No. 124 dated March 16, 2015 "On Approval of the rules for awarding the title of "Best Teacher of a Higher Educational Institution".
- 2. "The Best University Teacher" Award Rules determine the procedure for awarding the title (hereinafter the title) to teachers of Kurmangazy Kazakh National Conservatory who have high achievements in teaching and research in order to stimulate the professional development of teachers, support scientific research and educational innovations.
- 3. The following basic concepts are used in the Rules:
- 1) a competitor shall be a full-time teacher of the Conservatory, carrying out pedagogical activities who has submitted documents for participation in the Award in accordance with these Rules;
- 2) Conservatory Award Board shall be the Academic Board of Kurmangazy Kazakh National Conservatory.
- 4. The title shall not be awarded to the same person more than once in the next ten years.

2. "THE BEST UNIVERSITY TEACHER" AWARDING PROCEDURE

- 5. Citizens of the Republic of Kazakhstan who meet the following requirements participate in the in "The Best University Teacher" award:
 - 1) who are full-time teachers of the Conservatory;
- 2) with continuous scientific and pedagogical experience of at least five years at the time of submitting documents for the award.
- 6. Stage I of the award competition shall run at the university internally and held annually in November. Based on the results of the intra-university Award, by decision of the Academic Board, no more than 1 applicant per every 50 full-time teachers, shall be defined as the best teacher of the conservatory, who are further recommended to participate at the National stage of the Award. The results of the intra-university award competition shall be posted on the Internet resource of the Conservatory, indicating the qualitative and quantitative indicators of all applicants who took part in this Award. The National stage of the Award shall be held in December this year.
- 7. Information about the Award shall be posted on the Internet resource of the Conservatory in September of the current year and from that day it shall be considered announced.
- 1) To participate in the stage I of the award competition, applicants from among the full-time teachers shall submit the following documents through the information system of the Ministry of Education and Science of the Republic of Kazakhstan (hereinafter IS MES) as well as hard copies thereof: 1) application as per the template for participation in the Award in accordance with Appendix 1 hereto;
- 2) information in accordance with qualitative and quantitative indicators in accordance with Appendix 2 to these Rules;

- 3) annual work schedule, in accordance with Appendix 3 to these Rules;
- 4) personal record of personnel, certified at the place of work;
- 5) a copy of the identity <u>document;</u>
- 8. Documents shall be submitted through an information base and/or on paper in hardcover with continuous page numbering, containing a personal e-mail address and shall be certified by the seal of the HR department of the Conservatory. Supporting documents shall be attached in sequence according with Appendix 1 hereto.

The Competitor shall be responsible for the accuracy of the documents submitted.

The Academic Secretary of the Academic Board shall check the documents submitted by the applicants for compliance with the annexes to these Rules.

Documents submitted for the Award will not be returned.

The Academic Secretary of the Academic Board shall give an opinion on each applicant in accordance with the qualitative and quantitative indicators as well as on the annual work schedule.

- 9. In case if a competitor submits inaccurate or incomplete information, the Academic Secretary of the Academic Board shall submit to the Board a proposal to exclude him/her from the list of participants with written justification.
- 10. Points for qualitative and quantitative indicators and the annual work schedule of the competitors shall be calculated for each applicant and a rating of applicants shall be arranged based on the conclusions of the Academic Secretary of the Academic Board.

The rating of applicants shall be arranged in the form of a table according to a descending ranking system of points in the information system based on the qualitative and quantitative indicators points calculating algorithm and the annual work schedule of the competitors. The table shall be submitted to the Board for consideration.

- 11. The decision of the Board on awarding «The Best University Teacher» title shall be made by a simple majority of votes from the participating members. In case if Board members' votes are equal the vote of the Chairman of the Board shall be decisive. The decision of the Board shall be documented in a Minutes of the Meeting.
 - 12. The results shall be posted on the Conservatory's Internet resource.

- 2. For indicators 1, 3.1, 9.1 and 13, the applicant selects availability and attaches supporting documents for each position for which the answer is Yes. According to indicator 1, a diploma shall be attached, according to indicator 3.1 confirmation from the university, according to indicator 9.1 a Ph.D. diploma of a trained student, URL links to the defense announcement and thesis, according to indicator 13 DOI or Accession Number (Web of Science), or EID (Scopus).
- 3. For indicators 2, 7 and 12, the applicant shall choose no more than one of the specified options and attach supporting documents for each position. For indicator 2, a diploma of academic title shall be applied, for indicator 7 a certificate, for indicator 12 a patent, DOI and PDF file of an article in which the advantages of a patented invention are proved.
- 4. For indicator 4, the applicant shall select no more than three developed and/or conducted sessions and provide a URL link for each of them. Moreover, each type of activity can be selected several times.
- 5. For indicator 5, the applicant shall select no more than three developed training materials and attach supporting documents for each of them. Moreover, each type of training materials can be selected several times.
- 6. For indicator 6, the applicant shall choose no more than two measures to improve professional and pedagogical qualifications, and attach supporting documents. Moreover, each type of event can be selected several times.

- 7. For indicator 8, the applicant shall select no more than two facts of training outstanding personnel in the bachelor's and master's degrees, and attach supporting documents (copies of diplomas, certificates, DOI/URL and article reprints, confirmation of the management). Moreover, each type of preparation can be selected several times.
- 8. For indicator 10, the applicant shall select no more than two projects and/or programs and give their numbers (IRN).
- 9. For indicator 11, the applicant shall indicate the three output results in the chosen field of science, which give the highest scores (taking into account n the number of authors). For articles in international magazines, DOIs are given, or Accession Number (Web of Science) or EID (Scopus). For publications in magazines recommended by COXON, their DOIs or URLs (if available) shall be provided. For monographs and chapters, all outputs including ISBN, DOI, and URL (if any), as well as supporting screenshots or videos shall be provided. For articles of a project head, a management confirmation shall be attached. Articles included in the Top 1 and Top 10% in terms of the number of citations shall be taken into account only if at least 1 year has passed since their first publication (date must be specified).
- 10. After entering the data by the applicants, the calculation of all indicators shall be carried out automatically.
- 11. Changes in the database can be made only based on the conclusion of the expert group in case of any discrepancy between the quantitative and qualitative indicators shown by the applicant to the submitted documents.
- 12. After each change made according to the conclusion of the expert group in the database, the candidates' points shall be recalculated automatically.
- 13. The candidates' points shall be automatically calculated in the information system according to the qualitative and quantitative indicators points calculating algorithm.
- 14. Hard copy of documents for the Award competition shall be submitted in hardcover with continuous page numbering. Supporting documents shall be attached sequentially in accordance with Appendix 2 hereto.
